

## Palm leaf

## **Material description**

The products are made out of discarded palm lead cuts of the Adaka nut palm in India by a family business. The palm leaf cuts used are the remnants of the palms which normally rot on the ground. They are collected, cleaned with fresh well water, laid into a water bath and are mechanically pressed into a mould at 120 °C. The pressure process per individual piece lasts 45 to 90 seconds, depending on the size. No other additives are required for lamination etc. The post-drying process occurs in a oven heated with wood charcoal. Then the products are wrapped in film and cartons. Each article is unique and has its own structure.
